FIREWORKS BOOTH SALES LOTTERY DRAW APPLICATION ELIGIBILITY QUALIFICATIONS AND PROCESS

Chowchilla Municipal Code Title 8.24.060 – 8.24.190

Organizations must meet all of the following eligibility qualifications to submit an application:

- Only a fully completed application will be accepted at the time of submission;
- An application must be submitted during business hours between June 1 and June 30;
- Applicants must be nonprofit organizations, associations or corporations organized primarily for veteran, patriotic, welfare, civic betterment or charitable purposes;
- An applicant organization **MUST** have its principal and predominant meeting place within the designated Chowchilla city limits;
- An applicant organization must have a membership roster of at least twenty (20) members;
- An applicant organization must be organized and established within the Chowchilla city limits for a minimum of one year prior to the submission date of an application;
- An applicant organization is limited to one fireworks booth sales permit in a calendar year;
- If an applicant organization has multiple auxiliary or direct affiliate organizations the primary organization and one auxiliary or affiliate organization can submit an application for the fireworks booth sales lottery draw; if one of these organizations is selected the other will not be considered eligible to receive a permit for the same time period.

The selection process for the fireworks booth sales lottery draw is as follows:

- Permits will be assigned by the Chowchilla City Council at a regular council meeting on a biennial basis in July.
- First priority of a permit(s) will be given to veteran organizations that meet the eligibility qualifications listed above;
- The remaining available permits will be assigned through a random lottery drawing of all remaining applicants that meet the eligibility qualifications listed above;
- Applicants will be notified of their permit eligibility following the City Council meeting;
- An organization is eligible to hold a permit for two consecutive years.
