## **PLANNING COMMISSION**

Seven members act in an advisory capacity to the City Council on proposed changes to the General Plan for the physical development of the City; make recommendations on proposed zoning and land use, and exercise control over land subdivisions (City Municipal Code Chapter 2, Section 24\*). The Commission meets monthly at 7:00 p.m. on the third Wednesday of the month in the City Council Chambers, 130 S. Second St., Chowchilla.

## **HERITAGE PRESERVATION COMMISSION**

No less than five and no more than seven members make up this board provides recommendations to the City Council for the recognition, protection and promotion of the retention, revitalization and use of heritage resources in the City's Redevelopment Area (City Municipal Code Chapter 2, Section 25\*). The Commission meets as needed in the City Council Chambers, 130 S. Second St., Chowchilla.

## **AIRPORT ADVISORY COMMITTEE**

Seven members act in an advisory capacity to the City Council in all matters pertaining to administration, operation, development, improvement and maintenance of the Airport, except for leasing matters (City Municipal Code Chapter 2, Section 26\*). The Committee meets at 5:30 p.m. on the third Monday of April, July, October in the City Council Chambers, 130 S. Second St., Chowchilla.

## **PUBLIC SAFETY SALES TAX OVERSIGHT COMMITTEE**

Five members serve as an advisory body to review expenditures and appropriations of the public safety sales tax revenues to comply with the intended purposes defined in the Municipal Code (City Municipal Code Chapter 3, Section 13\*). The Committee meets as needed in the City Council Chambers, 130 S. Second St., Chowchilla.
