*Included in the base fee is a \$4.00 CASp Services fee (SB 1186) per state mandate. Governor Brown signed AB 1379 into law on October 11, 2017, that adds a state fee of \$4.00 on any applicant for a local business license, or similar instrument or permit, or renewal thereof. The purpose is to increase disability access and compliance with construction-related accessibility requirements and to develop educational resources for businesses in order to facilitate compliance with federal and state disability laws, as specified.

Under federal and state law, compliance with disability access laws is a serious and significant responsibility that applies to all California building owners and tenants with buildings open to the public.
