- B. Establish and maintain a continuous, safe, and easily accessible bikeway system throughout the city to reduce vehicle use, improve air quality, and provide public health benefits.
- C. Pursue local, state, and federal funding and establish a well-integrated network of pedestrian facilities to accommodate safe, convenient, practical, and inviting travel for pedestrians of all physical abilities; completing and repairing the sidewalk network; and providing safe routes to schools and parks.
- D. Create a community and regional trail system that offers a variety of different route combinations and enhances public access to future Ash and Berenda Slough trails.
- E. Transportation improvements including traffic calming measures that reduce congestion and improve traffic flow to reduce emissions from existing and new development.
