Environmental Justice

Environmental Justice is the fair treatment and meaningful involvement of all people, regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies.

Fair treatment means that no population bears a disproportionate share of negative environmental consequences resulting from industrial, municipal, and commercial operations or from the execution of federal, state, and local laws; regulations; and policies.

Meaningful involvement requires effective access to decision makers for all, and the ability in all communities to make informed decisions and take positive actions to produce environmental justice for themselves.

What is a Complete Neighborhood?

The term “**complete neighborhood**” is a neighborhood that accommodates a range of incomes where residents have safe and convenient access to the goods and services needed in daily life.

This includes a variety of housing options, grocery stores and other commercial services, public schools, open spaces and recreational facilities, affordable active transportation options, and civic amenities.

An important element of a complete neighborhood is that it is built at a **walkable and bikeable human scale** that reduces auto independence, and meets the needs of people of all ages, incomes, and abilities.




SB 743 – Vehicle Miles Traveled (VMT)

A means to measure traffic volumes that discourages suburban sprawl, reduces greenhouse gas emissions, and encourages smart growth development, complete streets, and multimodal transportation.


California's new rules ask developers to project VMT created by their projects and, if they reach a certain level, provide for mitigations by taking steps that can include:

- improving access to transit and local amenities,
- incorporating affordable housing affordable housing and/or
- providing incentives to increase transit use.



What is a Complete Street?

A Complete Street is an approach to planning, designing, building, operating, and maintaining streets that enable safe access for all people who use them, including pedestrians, bicyclists, motorists and transit riders of all ages and abilities.

Increase access points to recreation areas and green spaces


Build and Maintain Sidewalks, Crosswalks, Bike Racks, Bike Paths to Green Space and Shade Trees
