## AIRPORT ADVISORY COMMITTEE

Five members act in an advisory capacity to the City Council in all matters pertaining to administration, operation, development, improvement and maintenance of the Airport, except for leasing matters.

Meets at 5:30 p.m. on the third Monday of April, July, October in the City Council Chambers located at 130 S. Second St., Chowchilla.

## HERITAGE PRESERVATION COMMISSION – currently does not meet

This seven (7) member board provides recommendations to the City Council for the recognition, protection and promotion of the retention, revitalization and use of heritage resources in the City's Redevelopment Area.

The commission shall have not less than five and no more than seven members. The commission members shall be appointed by the City Council. Length of the term of office shall be four years. Representation in the following fields is desirable, based on the discretion of the City Council: \*\*\*

1. Recognized professional in local history, archaeology, preservation and/or cultural development;
2. The business of real estate;
3. Architecture/architectural history;
4. Licensed building contractor, experienced in the field of alteration, repair and remodeling;
5. The business of banking/mortgage and loan;
6. Landscape architecture; and
7. Urban planning.

## Measure “N” Public Safety Citizen’s Oversight Committee

Five-member Citizen’s Oversight Committee to annually review expenditures and appropriations of the tax revenues to ensure that all such revenues are spent or appropriated for the purposes and uses set forth in Ordinance No. 493-18. Each January at its first meeting, the commission members shall elect from its membership a chair and vice chair. The officers shall hold office for a calendar year in which they are elected and until their successors are elected and sworn into office.

## PLANNING COMMISSION

Five members act in an advisory capacity to the City Council on proposed changes to the General Plan for the physical development of the City; make recommendations on proposed zoning and land use, and exercise control over land subdivisions.

Meets monthly at 7:00 p.m. on the third Wednesday of the month in the City Council Chambers located at 130 S. Second St., Chowchilla.
