Hi, could you please have this read into the record for tonight's meetings? Thank you,

I want to take the opportunity to thank the council for doing this very important work despite their personal objections to it. You'll understand that simply because something has not been an issue for you personally, that does not mean the issue does not exist, and that it doesn't affect others in meaningful ways. Chowhilla deserves a council that represents all parts of our community.

I want to ask that you set aside your personal ambitions (political and otherwise) and choose what is best for all of our community. We do not need to change the way the mayor is voted in, we simply need to change the way the 5 member council is elected. Nobody in the community has asked for a change in the structure of our council - that idea has been floated internally by the council and staff from the start of this process. I heard personally from Mr. Chavez and Mr. Ahmed very early on that the council wanted to change the structure to 4 seats, and i have also been told by others that this was recommended to the council by paid city staff as a way to protect incumbents. It comes at no surprise that Mr. Tilton's presentation and slides changed between his first and second presentations given on 4/9 & 4/23. Slide 7 was changed the second time around to remove language specific to 5 districts, and in watching the recorded meetings, the shift in language is easy to spot. The question is who, if not a member of the council or paid staff, reached out to NDC to prompt this sudden change in language and the production of so many maps of 4?

This subversion of the districting process is shameful and deceitful. I don't believe this is how each of you would run your various businesses, it certainly isn't how you should run the city.

As stated before, I am in favor of map 504, with districts 1, 2, 3 & 4 given priority for election in 2024. I represent a large group of Latino and non-Latino voters who feel this map is the best representation for our community.

Do what is legal, and what is right for our community.
