

Public Safety Transactions and Use Tax Citizen's Oversight Committee

The Public Safety Transactions and Use Tax Ordinance specifies the formation of a five-member the Citizen's Oversight Committee that will annually review expenditures and appropriations of the tax revenues to ensure that all such revenues are spent or appropriated for the purposes and uses set forth in the Chowchilla Municipal Code Chapter 3.13.120. The City Council shall appoint Committee members from the completed applications received by the announced submittal date.

Each Committee member shall be a resident of the City at the time of appointment and shall remain a resident of the City while serving on the Committee. Those applicants demonstrating the experience, knowledge, civic-mindedness and/or community involvement deemed by the City Council to be of sufficient merit, and without direct financial conflict of interest, to best serve the interests of the Committee shall be given preference. Should applications be received that are insufficient to satisfy appointments meeting the preferred qualifications, the City Council reserves the option to appoint members without regard to such preferred qualifications. Preferred qualifications are guidelines for the City Council and not definitive or controlling as to final action on appointments by the City Council.

The Committee Chairperson and Vice Chairperson shall be selected by the members of the Citizen's Oversight Committee. Each subsequent January at its first meeting, Committee members shall elect from its membership a Chairperson and Vice Chairperson. Their term of office shall be for the calendar year in which they are elected and until their successors are elected and sworn into office. Meeting dates and times will vary and will be established by the Committee and or City staff to meet required timelines to complete obligated tasks and duties.

The Committee shall receive the assistance of City staff and shall issue an annual public report on the expenditures and appropriations of the tax revenues. The Committee shall undertake such additional duties as the City Council may designate.
